



## **[SKELETON] ARBITRATION AGREEMENT**

### **Parties**

The Parties have jointly agreed that the dispute be referred to **Sport Resolutions (UK)** for arbitration.

The following terms shall apply:

1. By agreement of the Parties, the Arbitration shall be heard by a single Arbitrator [or by three Arbitrators – specify basis on which they have been selected i.e. by SR or one by each of the parties etc], namely [add additional names as required] c/o **Sport Resolutions (UK)**, 1 Salisbury Square, London EC4Y 8AE ("the Arbitrator"), appointed by **Sport Resolutions (UK)**.
2. The Arbitrator(s) shall have jurisdiction to decide [set out brief description of issues to be decided by arbitration, as agreed by parties].
3. The dispute will be submitted for determination exclusively to the Arbitrator(s).
4. The Arbitration shall be governed by the **Sport Resolutions (UK)** Rules for Arbitration and the Arbitration Act 1996 save as specifically varied by this Agreement.

5. The Decision [or Award as appropriate] of the Arbitrator(s) shall be final and binding on the Parties. By agreement of the Parties, any right of appeal on point of law under section 69 of the Arbitration Act 1996 is specifically excluded.
6. [The Decision [or Award as appropriate] of the Arbitrator(s) (and the reasons upon which the Decision/Award is based) shall be public although the hearing shall be in private- delete as agreed]
7. Costs

Each Party shall be responsible for its own costs. Further, in the absence of any express award by the Arbitrator(s), the parties shall each be responsible in equal shares for the costs of the Arbitrator(s) and **Sport Resolutions (UK)**. Payment shall be made in full by all parties to **Sport Resolutions (UK)** within 7 days of receipt of invoice. The Decision/Award will not be released by **Sport Resolutions (UK)** to any party until all invoiced payments have been paid in full.
